PRESENTATION

The BritishSpanish Society is a registered charity and a non-political organization founded in 1916 by a group of British people whose purpose was to extend a hand of cultural friendship to Spain in the middle of the politically challenging circumstances of the First World War. In 2016 we celebrate our 100th Anniversary.

Our constitutional objective is to educate the people of the United Kingdom and Spain about each other and to promote cultural relationships and a mutual understanding between both countries.

Today, we are a growing organization with over 900 members. Our membership profile is very diverse and captures a broad section of British people with an interest in Spain as well as Spaniards living and working in the United Kingdom. We are becoming increasingly important in encouraging the social and cultural links between British and Spanish people.

The Society's activities revolve around the Events Programme, a Scholarship Programme and the publication of La Revista, our quarterly magazine. Our funding relies on membership fees, funds raised from events and contributions from corporate and institutional sponsors.

La Revista is one of the most tangible benefits we offer to our members. It is the flagship of the Society and it forges our identity through covering topics of interest to our membership, events we organize, helping us recruit new members and serving as a promotional platform for our corporate supporters. Circulation has increased from 1,000 to 3,500 in the last 18 months and we plan to continue growing to match interest in the Society.

As a registered charity, a Board of Trustees chaired by Jimmy Burns Marañónleads us, with support from an Executive Council. Both teams provide a solid institutional governance framework. Dame Denise Holt and Sir Stephen Wright, both former British Ambassadors to Spain, preceded Jimmy Burns Marañónas chairs. Three enthusiastic part time members of staff and highly committed volunteers support all of our activities.

Our fund-raising events range from social networking evenings and classical concerts to private art gallery viewings, conferences, and visits to the Houses of Parliament. In April 2016, and marking the centenary of the BritishSpanish Society, we hosted a Gala dinner at the Dorchester Hotel in London with over four hundred guests, and amongst them Queen Sophia of Spain and HRH the Duke of York as honorary special guests.

During the last ten years, the BritishSpanish Society – formerly known as AngloSpanish Society – has awarded more than seventy postgraduate students (54 scholarships + 17 bursaries) in their pursuing of their projects and studies with the help of different corporate supporters. The majority of them are PhD candidates, with a few of them still at master's level, mainly of Spanish nationality. Their studies focus mainly on medicine (12), history (11), engineering (9), literature and linguistics (9), music (9), politics and economics (6), with minor representation from other disciplines such as architecture and urban planning, physics, chemistry, biological sciences, marine archaeology, mathematics, international relations, sociology and anthropology, philosophy, law, film and drama studies.

Our long-lasting principal supporters have been Telefónica, BBVA and Santander Universities, as well as Ferrovial, who supported our Scholarship Programme until 2016. We are immensely proud of the fact that we have acquired three new Principal Supporters since 2016: Mahou San Miguel focusing on gastronomic projects, Plastic Energyon projects related to different areas such as life cycle analysis or environmental protection and Sabadell Fundaciónfor the arts and humanities. It is important to remember the kind and generous financial contribution of former Principal and Corporate Supporters BUPA and Cuatrecasas Gonçalves Pereira. Last but by all means not least, the BritishSpanish Society has joined the University of Wales Press and their Latin American Studies Series to support research in Hispanic Studies and to provide a channel among researchers, academia and the Society. This partnership offers a unique opportunity for researchers to win a prestigious prize as well as having their theses considered for publication by an established university press with strong links in Hispanic Studies.

Over seventy leading representatives of the diplomatic, corporate, and academic world attended the TheBritishSpanish Society's annual scholarship awards ceremony at the London Belgravia residence of the Spanish Ambassador on 24th May 2018.

The occasion marked the tenth year of the Society's prestigious programme, which celebrated the academic successes of eight British and Spanish students who were awarded full scholarships in collaboration with our six Principal Supporters, namely BBVA, Mahou San Miguel, Plastic Energy, Sabadell Foundation, Santander Universities and Telefónica. Following this very special anniversary, the BritishSpanish Society awarded a scholarship of its own thanks to the very generous donations received from both our supporting patrons and individual members.

Furthermore, it reviews the potential of blockchain for social innovation together with its strategic implications to many economic sectors and its main implementation challenges.

PROJECT

Block Copolymers are macromolecules composed of groups of different repeated units. In the simplest case, diblock copolymers can selfassembly into periodic ordered structures in the mesoscale, and its morphology and overall properties can be modified by the presence of nanoparticles. We want to study the effect that nanoparticles have on the block copolymer nanocomposite overall morphology, as well as the assembly of colloids. Complex systems such as anisotropic nanoparticles will be examined.

Spinal cord injury (SCI) is a highly debilitating trauma with no effective treatments. One of the most promising new avenues of treatment is to combine axon growth-promoting and tissueengineering strategies to create a permissive and encouraging environment for injured spinal nerve processes to regrow. Our proposal consists in combining a novel hydrogel that works as a scaffold and is capable to deliver locally Epac 2 agonist that regulates intrinsic pathways boosting neurite growth. Promising results have been achieved using different models in vitro, such as primary cell cultures, and in a recently established Ex vivo model for SCI.

We will apply global optimization techniques with the goal of finding robust locations that work well under various demand scenarios. This will include heuristic as well as exact solution methods. The methods will be tested using real world data sets of British and Spanish cities.

Antimicrobial resistance is a global public health threat and Gram-negative human pathogens top the WHO priority list of multidrug resistant bacteria (MDR). Until the development of new antimicrobial agents, colistin is likely the only antibiotic left to treat infections caused by such pathogens. Unfortunately, colistin resistance is already emerging, and very rapidly among bacteria of animal origin, due to the swift spread of a transmissible gene, mcr-1. A better understanding of the sources and mechanisms of dissemination of colistin resistance is urgently needed to design containment strategies and prevent further dissemination of colistin resistance to human MDR pathogens.

In this project, we are developing a novel class of versatile sensors that can be used to detect a wide range of problematic water contaminants without need for expensive equipment, trained personnel and a laboratory environment. The molecular sensors that we are designing change colour in the presence of a specific contaminant, thereby, indicating if the water is safe for human consumption.

The eventual goal of this project is to develop a pen-side diagnostic technology for the detection of infectious animal diseases. Such technologies are particularly important for diseases with no cure.

This project will involve fabrication of the electrodes, immobilization of DNA, electrochemical analysis of DNA spiked samples and (possibly) construction of a portable electrochemical reader which could be interfaced with mobile devices.

The source material for the project would be predominantly archive recordings available in the UK and also if funding allowed a short research trip to the Museo do Pobo Galego (Galician Ethnographical Museum), in Santiago de Compostela.

This research will be looking for shared elements such as repertoire, common melodic themes, common rhythmic devices, dance idioms, harmonic structures, approaches to improvisation, subject matter.

As a performer and composer who also predominantly works in the fields of Jazz and World music, improvisation will be central to these new works. My extensive experience in Afro-diasporic fusion music and Venezuelan neo-traditional forms, have cemented in my own practice the importance of music to be a vehicle in which cross cultural collaborations can transcend national identities and spoken language.

Betalains can act as potent antioxidant, anticancer, anti-microbial molecules, as well as enhance plant tolerance to adverse environmental conditions such as lack of water or high salt. Given these benefits, it is important to further understand the biosynthetic pathways leading to betalain production and accumulation in plants and how this knowledge can be used to engineer new industrial production hosts using model organisms like brewer's yeast (Saccharomyces cerevisiae) or bacteria (Escherichia coli), as well as new promising mechanisms for crop resistance in the frame of an ongoing environmental change.

The project is aimed to achieve the production of a functional natural compound in Saccharomyces cerevisiae, a microorganism with more than a century of history with Mahou since its origins in 1890. In the other hand, the food industry is witnessing a growing interest in the field of functional food, combining nourishment and health improvement in the same products. Supporting the creation of strains of yeast with the capacity of producing beneficial compounds would translate into a new way of promoting society's progress and welfare with the same common tools the company has been using for its own products.

My Cell-Derived Vesicles (CDVs) are a modular and universal delivery system to treat a huge spectrum of diseases, such as cancer or genetic disorders.

Chemotherapy drugs, proteins, and nucleic acids have a vast potential to treat human diseases. However, they have to reach the site of disease, get inside the right type of cell, while avoiding destruction by the immune system, the human body's defences. To tackle these challenges, I have created nano-vesicles inspired by nature. These containers are obtained from living cells, which allow me to control the cargo that is loaded and in which cell they get internalized.

The British Institute in Madrid was set up seventy-five years ago in August 1940. Despite this important anniversary, the reasons behind the foundation of the British Council's only school remain relatively unknown. This study hopes to address the gap in the literature by suggesting that the purpose of the British Institute in Madrid's foundation was to counter Nazi German and Fascist Italian propaganda, keep Spain out of the Second World War, and help Britain's Secret Intelligence Services win the war.

PROJECT
